# **Expand Wildlife Safety Zones**

The Wild Friends helped pass a

memorial in 2011 to create a wildlife safety zone pilot project to reduce animal-



vehicle collisions (see Update on p. 2). Wild Friends students could urge the state to find out where other dangerous areas are for animals and humans in our state, so that the project can expand and help save the lives of deer, bears and mountain lions. as well as humans!

#### Choice B: Get Outside! **Outdoor Classroom Study**

Last year, the Wild Friends helped to pass the Children's Outdoor Bill of Rights, which encourages all state agencies to do more to get students outside. This year, Wild Friends could ask the legislature to study the possibility of increasing the amount of outdoor classroom experience that each student receives.

## Expand Wildlife Safety Zones (ballot choice #1)

The Wild Friends have helped stop wildlife-vehicle collisions in New Mexico in the past, and we can do it again! Two state agencies, the Dept. of Game and Fish

and the Dept. of Transportation, need to hold a workshop to find out where the most animal -vehicle

collisions occur, so that they can expand their pilot project (which the Wild Friends helped pass in 2011!) to the entire state. This is really a problem in states like New Mexico, where lots of big critters such as deer, bears, and mountain

> lions cross highways. The state agencies need a memorial from the legislature urging them to hold a workshop. This memorial may lead

to a bill to have wildlife safety zones across the state!



The 2011 Wild Friends memorial, HJM 10, is happening! The pilot project will be on US Hwy 64, from Tierra Amarilla to Chama. Soon, there will be flashing lights to warm drivers at dusk and dawn to be aware of wildlife that may be crossing the road. Way to go, Wild Friends! You truly make a difference.

## **Outdoor Classroom Requirement (ballot choice #2)**

What you learn in school is governed by "state standards" that all public school teachers must follow. This includes subjects such as math, science, English, social studies and art. Does all learning have to take place inside a classroom though? Isn't it

great to get outside, and even better, to learn outside? The Wild Friends could ask the legislature to look at ways to in-

clude outdoor learning experiences in the state standards, so that all



students get a chance to be outside more. After all, the studies show that being outside boosts brain power!
